



ChatCraft - ChatCraft enables you to efficiently tag and review chat data (Teams, Google Chat, Slack, etc.) on a per chat, per day, or conversation level and associates attachments in-line with their chat conversations. Users can visualize chat history over timelines, revealing key trends. Finally, it allows you to export only the relevant messages without redacting countless other unresponsive messages in your productions.



Images - Lineal Images is an intuitive review tool for image files integrated with Relativity. Within Images, you review images in a tile format grouped by category based on concepts. Reviewers have the ability to search, identify, and tag images (i.e., logos, graphics, pictures) en mass, within or across their categories.



BotDetector - Designed to eliminate junk and provide logical culling, Lineal's BotDetector identifies auto-generated messages and provides social networking scores to eliminate these non-relevant documents. It uses social status identification to intelligently understand the senders relevance. BotDetector culls, on average, an additional 15% of all communications documents.



PrivFinder - PrivFinder combines privileged taxonomy, advanced analytics, and a database with over 100,000 known privilege actors to provide users with a better, faster way of identifying privileged documents. It analyzes communication data and allows users to input case-specific information (communications involving aligned and adverse parties and law firms, in-house legal staff, and professional signatures, etc.) to provide the likelihood of privileged communication.



STR 2.0 - Adds an invaluable capability to Relativity that allows users to quickly understand the context of keyword hits without having to view the entire document. STR 2.0' s advanced hashing algorithm allows you to quickly suppress false positives from your workspace.
